**PUBLIC HEARING:**


Golden went through the 2024 Budget in detail, explaining the changes from the current year budget & stating there has been no changes since the Budget Workshop.

Public Hearing Notice was published & posted. The Entities received Notice with the Proposed Budget in the date requirements according to the Property Tax Code.


No public present for the Public Hearing.
